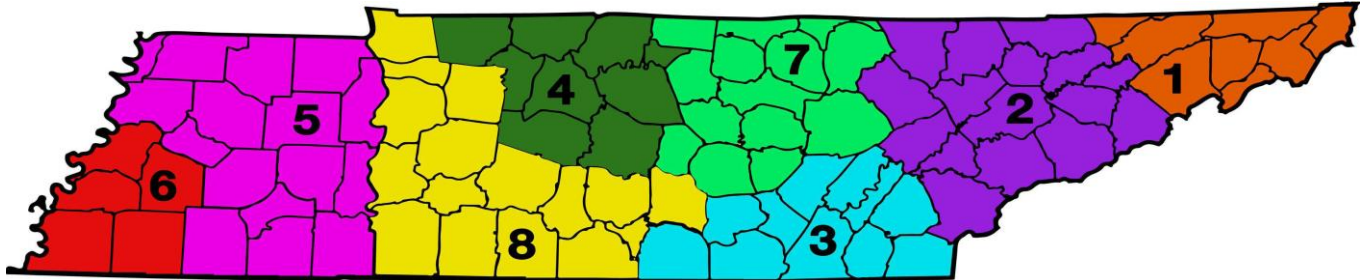

- Tennessee Ryan White Part B Program will not support family plan premiums in 2025 unless all family members are HIV positive. If a family member is paying the premium, IAP will provide financial support copays and deductibles on HIV positive family members only.
- Tennessee Ryan White Part B Program will not support COBRA plans in 2025. Loss of job is a special enrollment criterion. Individuals are eligible to receive health insurance under the Special Enrollment Period.
- Tennessee Ryan White Part B Program will not support off-market plans for individuals whose income is over 100% FPL.
- Tennessee Ryan White Part B Program will not provide financial support for on or off market plans when client is eligible for an employer plan. All exceptions will need to be approved by Central Office.
- To ensure a plan start date of January 1, 2025, updated insurance information must be received by IAP NLT December 15, 2024.
- Any exceptions to the designated plan must be approved by Central Office.
